## Tournament Rules

1. This tournament will consist of Team, Doubles and Singles Events. All Huntsville USBC league members of the HUSBC Association are eligible to enter the tournament. USBC members who are eligible for another association championship tournament must bowl 21 games in a league within the HUSBC Association iurisdiction to be eligible to bowl, who are 50 years of age as of September 1, 2021. (Tournament month)
2. Multiple participation is permitted in Doubles and Team. First set of Doubles will count toward All Events. All Events will only include Doubles and singles Events. Bowlers must enter both Doubles and Singles events; however, they may bowl at different times. An optional Team Event is being offered.
3. For multiple Doubles you must change partners. For multiple Teams 2 players must be different.
4. Bowlers shall use their highest 2020-21 Sanctioned average of 21 or more games. Bowlers not having a 202021 average may use their highest 2021 summer average of 21 games or more. Bowlers not having a book average or summer average may use a current league average of 12 games or more. Bowlers not having these averages must bowl scratch (Rule 319b)
5. The 10 -pin rule (319a (2) is waived. However, bowlers who have qualified for prize winnings of $\$ 600$ or more within the previous 12 -month period must provide tournament management with necessary information as required by Rule 319d. Handicap will be $90 \%$ of the difference between bowler's average and 230 .
6. All prizes will be awarded on a handicap basis. $100 \%$ of prize fund fees collected will be disbursed to Handicap winners. One prize for each five (5) entries in Doubles, Singles and Team Events, All-Events are one prize for each ten (10) entries. Scratch champions will receive certificate only.
7. Singles and All-Events will be subdivided into three (3) age categories as shown on the front of this entry form, with Men and Women separated.
8. Unless stated to the contrary above, all USBC rules and regulations will govern this tournament.
