Bowl multiple teams (4 persons, mixed), must change at least two members for multiple cash.

Bowlers bowling Doubles must also bowl Singles at same time.

Rules Inside. Please Read!

2022 - MYRTLE BEACH/GRAND STRAND TOURNAMENT RULES AND REGULATIONS

1. This tournament is certified and operated under the tournament rules of, and open to all TNBA and USBC associates. Please submit a copy of your current membership (TNBA and USBC) cards along with your tournament application. Any bowler who cannot present their membership card prior to bowling, will be required to purchase the necessary membership card on site at a cost of \$26.00 for TNBA, and \$26.00 for USBC cards. Refunds will be given if the cards are presented by the end of bowling. **NO MEMBERSHIP CARD STUBS WILL BE ACCEPTED.**
2. The tournament will consist of MIXED TEAM, DOUBLES (any combination) and SINGLES events. Doubles/Singles will be bowled at the same time. There will be separate divisions for men and women in the Singles event. Men cannot enter the women's singles event and women may not enter the men's singles event. If bowling more than one team, please **SUBMIT ALL ENTRIES** at the same time. **HANDICAP** will be 90% of 210 for men and women. Handicap will be figured individually per bowler. **TOURNAMENT DEADLINE IS FEBRUARY 7, 2022.** If you wish to **RE-ENTER** any event, you may do so (if space available) by submitting a separate entry form by the registration deadline. **PLEASE SEE RULE #6.**
3. **ENTRY FEE** is \$35.00 per event. All fees in the form of **BANK or CERTIFIED CHECK and MONEY ORDERS** are to be made payable to Myrtle Beach/Grand Strand Senate TNBA and must accompany the entry application.
4. The entry application must include the **FULL NAME (NO nicknames), INDIVIDUAL ADDRESSES, TNBA and USBC numbers for EACH BOWLER. OMISSION WILL DELAY PROCESSING OF the entry application.**
5. Entrants must use their highest **CERTIFIED LEAGUE AVERAGE**, based on 21 games for the 2020-21 season. **NO SUMMER LEAGUE AVERAGES WILL BE USED.** Sport and Challenge League averages must be converted per USBC Conversion Chart. All others must use their highest current certified league average at the time of bowling. A league sheet signed by the League Secretary or the TNBA Senate President is required. If none of the above, the bowler must enter with a 210 average. The 10-pin rule, USBC rule #319a-2 will apply. USBC rule 319d – Reporting Prize winnings (social security number required with \$300 or more winnings in a single event, etc) will apply. USBC rule #319c – Average adjustment will apply. If you have been re-rated before, you must submit your re-rated average even if the entrant did not accept the adjusted average. Failure to do so, will disqualify you. Please check at the registration table prior to bowling.
6. Multiple entries will be permitted. However, a bowler may cash only once with the same partner. Teams will be mixed, a combination of four (4) bowlers, men/women; doubles (any combination); and singles. Prize fee will be returned 100%. The Singles event may be re-entered (after bowling a complete Doubles/Singles squad); bowler may only cash once in Singles. One (1) prize will be awarded for every ten (10) entries in each event Team, Doubles and Singles. Any bowler who has held a PBA membership card within the the past (5) years will not be allowed to bowl in this tournament. A bowler may only bowl on one entry per squad.
7. Team Captains must report to the Tournament Office at least one hour before the time scheduled to bowl and submit missing TNBA and USBC cards for their team members.
8. Bowlers are responsible for verifying their own average, whether submitted by the bowler, his/her team captain or others. If the submitted average for a bowler is higher than his/her true average, he/she must bowl with the lesser handicap and no additional pins will be given him/her. If the submitted average is less than the true average, he/she shall forfeit all prize money and any he/she helped to make. Any change in average must be submitted prior to bowling. See (USBC rule 319a-3 and 319a-4).
9. No change in line-up will be allowed once application has been submitted and processed.
10. Replacements and substitutes shall be permitted, and the bowler must bowl in the position of the original entrant. All rules and regulations herein likewise apply to replacements and substitutes. All changes must be made one hour prior to bowling.
11. Errors in scoring must be reported to the Tournament Director's office within 48 hours after games bowled.
12. Tardy players will start in the frames being bowled with zero given for each frame missed. If a team refuses to start because a full-line-up is not present, all games which they decline to bowl will be forfeited. No blind scores shall be permitted, and the bowler must bowl with and on the same lanes and at the same time his/her team bowls.
13. After the entry has been received, no fees shall be refunded, except in dire emergencies such as strikes, lockouts, national emergencies, fires, natural disaster, etc. over which management has no control.
14. Any appeal or protest regarding tournament scores or rules must be made in writing to the tournament manager within 72 hours of the infraction. The action of the committee shall be final unless an appeal is made in writing in accordance with USBC rules.

The Tournament Committee reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA and USBC. Any rule not covered herein shall be governed by USBC rules.

ITEMS OF IMPORTANCE

We hope this memo finds everyone healthy and staying as safe as possible.

Attached is a copy of the 20th Annual Myrtle Beach/Grand Strand Tournament application. There have been a few CHANGES in our RULES. Please take some time and read through them for the updates. We also have a new bowling schedule.

PLEASE NOTE THE FOLLOWING:

1. Although we have gained a slight advantage during the past 18 months, we continue to be plagued by the CoVid-19 virus pandemic and Delta variant we find the need (at this time) to continue to practice various safety methods. We respectfully request that all bowlers and visitors wear a mask when in any of the common/community areas (concourse, bathroom, snack counter, bar, etc).
2. The bowling center will have sanitizing stations available throughout the center for your convenience. The tables and chairs will be socially distanced (as per bowling center requirements).
3. There will be three squads for the TEAM event each weekend and three squads for the DOUBLES/SINGLES event each weekend. Depending on the number of entries into the 4:30 pm TEAM squad, additional DOUBLE/SINGLES entries may be accepted.

DOUBLES/SINGLES – 8:00 AM TEAMS – 1:00 PM & 4:00 PM

4. To eliminate the normal “traffic jam” that occurs during check-in, and to facilitate the check-in process, we are again requesting all coordinators to submit copies of the current USBC and TNBA cards with the entry form for each of their bowlers. These copies may also be submitted separately by email to: conniemanigo@gmail.com at the time the entry is mailed.

6. Brackets will be offered through individual entry forms at a table specifically set up for brackets. This will replace the single sign-up sheet used in the past. This table and area will be sanitized after each shift.
7. USBC has allowed “alcohol” to remain on the list of permitted cleaners for bowling balls during tournament play. However, alcohol is the only ball cleaner approved to be used to clean your ball during the competition. All other approved cleaners may be used PRIOR to competition or at the COMPLETION of competition ONLY.

Deadline for submitting the tournament application is FEBRUARY 7, 2022. We do not RESERVE SPOTS, so to insure you get the squads and time you want to bowl, we suggest you get your applications in quickly. We reserve the right to cancel any squad that does not make.

We have put the above precautions in place, while we await the health organizations to gain control over the CoVid-19 virus. However, based on the conditions at the time of the tournament, some of these safety precautions may change. We are making every effort to provide the safest possible environment for you during our tournament and we reserve the right to cancel the tournament if situations are deemed unsafe.

We look forward to seeing everyone in February/March 2022.
